Invoice for uncollected amounts was delivered to the college. B. Miller clarified that the invoice delivered to the college will be paid to Comstar, it does not come to our office. Supplies are good.

Chief Calkins reported on the storm. Significant damage to trees and poles but there were no injuries. He reported Captain Moore continues to work on the Cares Act and FEMA reimbursement. He stated that he is super excited with the way dispatch is going. Any issues are reported to Chief and he speaks with Mark or Ray; it's definitely working. Chief met with MHC regarding COVID testing, he expressed to them an interest in having District 2 employees be tested at their facility, since we are first responders to the campus and the water department goes into the buildings to check and install meters. They will be getting back to him on that. Sprinkler and fire alarm tests for the new sprinklers and fire alarms at 1837 Dorm full acceptance and Torrey will be done in the morning. Chief provided a draft of the stuffer to go into the water bills regarding the fire truck.

# Dental Insurance Credit
