Sand and Gravel Pit Proposed Expansion:

The Superintendent M. Aiken spoke with Mr. & Mrs. Salthouse who prepared a letter for the Superintendent regarding the expansion of the sand and gravel pit. F. DeToma read the letter to all in attendance (the Salthouse's were not in favor of the proposed expansion). M. Aiken advised the Salthouse's to send their letter to the Planning Board as the Board of Water Commissioners do not have the authority to prohibit an activity that is permitted by the municipality. M. Aiken explained the zoning for our water source, and also stated why he is concerned with the expansion of the gravel pit. The Superintendent has proposed additional protocols for the expansion, and he will be going beyond what DEP recommends for our water sources protection.
