Open Meeting Law:

K. Bedard would like to have a refresher on the laws stating that she feels over time we may become lackadaisical with the formalities that we need to uphold. T. Cauley will prepare packets for the Commissioners and we will review the Open Meeting Laws at our next meeting.

2023 Capital Jobs:

T. Cauley began the discussion with the Brockway Lane – Faculty Lane project which would consist of 1300' of new pipe, 3 hydrants and valves. He has spoken with the college and they are entertaining the idea to give us some sort of help/compensation for the project. T. Cauley is waiting for them to respond back.

Morgan St. project would be the second job that we would like to get done this upcoming fiscal year. This project would help with increasing the flow of water.

Discussion for bonding in 2026 (to contract out for College St). K. McKenna asked if there were any grants out for water departments. T. Cauley stated that there is really nothing out there for districts just mainly for the towns, but was told that rewording for these grants is being done to include districts and he will keep abreast of the matter.

Other Business:

- ISO (insurance) came in and inspected our records. The agent was Impressed with our record keeping, and was with us for about 25 minutes, stating if he needed anything else he would let us know. Then moved on to the Fire Department.
- In house posting; T. Cauley reached out to several communities in regards to job postings. We are the only district that has this in our policy handbook. When speaking to other departments they stated they don't advertise but verbally tell their employees that if they are interested in the position to apply for it. Amherst and Hadley both had candidates from Inside the departments chosen, when offered the position they declined. This is when they looked outside their departments. For supervisory positions all prefer inside hires who know the system. Several departments who T. Cauley has spoken with are now inclined to follow our hiring policy and adding to their employee manual.

- CUSI is billing for ECH users. \$1.50 charged by Plaid for check users and also .20 cents for each check. T. Cauley suggested that we stop the ECH on line and just do Credit or Debit cards. Commissioners agreed.

DeToma moved to deny the abatement as our equipment is in working order and no leaks were found. D.
