Billing System Upgrade:

Emergency Response Plan:

The plan is not due till December 2021. Our response plan is in the process of being completed.

Morgan Street Project:

The Water Department will begin work at 3:00 P.M. and work till 11:00 P.M. the water will be shut off. They will cut and cap the 6" main. Interconnections to the college will need to be shut off, this will happen at 7:00 P.M.

Other Business:

- M. O'Meara attended the Prudential Committee meeting regarding the parking for hikers and her property.
- Pete Michaels from DCR has made signs for the area at Elmer Brook and has posted them.
- At the Prudential Committee meeting J. Menard explained issues and concerns regarding people accessing Lithia Springs via District 2 Elmer Brook property and other privately owned property. J. Menard spoke with Rep. Dan Carey's office and they are aware of the issues. A motion was made by J. Menard to let the state or a trust have the option to purchase parcel 58/19 off Amherst Rd. The motion was approved.
- Juneteenth, has been declared a state holiday. The Town voted to add it to the paid holiday.
